

Dear Student,

In these moments of long-lasting uncertainty and concern for the future, Università Cattolica del Sacro Cuore has decided to offer concrete support to the students and their families, to face the heavy economic consequences of the epidemic caused by the Coronavirus and to help prevent the risks of dispersion of a valuable Human Capital.

The University, through the establishment of the Agostino Gemelli's Education Fund to support studies, intends to repeat a facilitation for the payment of university contributions to students enrolled in the 2020/21 academic year who have found themselves in situations of serious economic difficulty.

Students who are regularly enrolled in a Undergraduate or Graduate programme or a Single Cycle programme, whose families have suffered a sudden deterioration in their economic condition and are in a situation of serious difficulty due to the health emergency, may apply for a benefit to pay tuition fees.

Students who in the academic year 2020/2021 are excluded from this form of benefit are:

- the students who, during the current academic year, have already obtained special benefits by Commissions for first and second levels.
- international students who received LT/LM/LCU International Scholarship special benefits.
- students who, during the current academic year, have received one or more scholarships.
- students who are not, at the time of application, regularly enrolled in a year of the course.
- students already exempted, for various reasons, even partially, from university contributions.

The acceptance of applications will be at the unquestionable discretion of the Agostino Gemelli's Education Fund to support Studies Commission, presided over by me and made up of representatives of the Pastoral Centre, the teaching staff and the technical-administrative staff of the University.

In order to obtain the funds, applicants must meet the requirements specified below.

## **ECONOMIC REQUIREMENTS**

The causes of the sudden deterioration of the family economic condition should, as a rule, belong to one or more of the following cases concerning a family member receiving income:

- Termination of employment
- Suspension or reduction of working time (lay-off and other social security benefits)
- For the self-employed and freelancer, a substantial reduction in turnover as a result of the closure or restriction of the activity carried out in implementation of the provisions adopted by the competent authority for the coronavirus emergency
- Death or severe illness

The above must be carefully substantiated through employer documentation for employees, self-certification for self-employed and freelance workers and, where necessary, through health-related documentation.

The self-certifications must report, if the deterioration of the economic conditions of the family depends on negative events of an economic activity carried out in a corporate form, the data of the financial statements for the period January-April 2020. It will also be necessary to provide the financial statements as at 31 December 2020.

The Commission may also request additional documentation or make requests for further information, where necessary, for a more accurate reconstruction of the situation.

## **EDUCATIONAL CREDITS**

Students, with the exception of those enrolled in the first year of the course, must certify that they have acquired and recorded, by 30 October 2020, the following minimum number of educational credits (ECTS minimum) for their entire academic career:
